As director of local 1, Juanita Gallant represents all UPSE members whose primary work location lies west of the western boundaries of the City of Summerside (and who are employed by the Civil Service bargaining unit, a provincial government agency, board or Crown corporation).

As director of local 3, Merilla Crossman represents all UPSE members whose primary work location lies west of the county line dividing Prince County and Queen's County and east of the western boundaries of the City of Summerside (and who are members of the Health bargaining unit as well as all UPSE members whose primary work location is the Stewart Memorial Hospital in Tyne Valley).

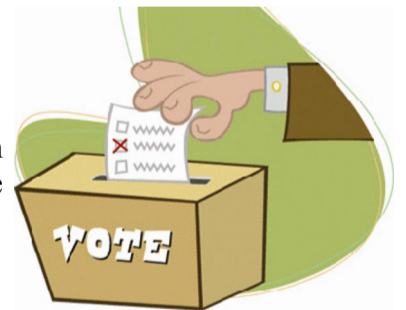
Chrissy Murphy

As director of local 7, Chrissy Murphy represents all UPSE members whose primary work location is in Queen's County (and who are members of the Department of Health bargaining unit employed in general hospitals, psychiatric care facilities, addiction services, or at Sherwood Home - and those members of the Department of Social Services and Seniors employed in the adolescent group homes).

To be eligible for nomination as a director, a member of the applicable local must have been a member in good standing for at least the previous twelve months, be nominated by a current member in good standing of the applicable local, and have completed the *You and Your Union* or equivalent course.

*Note: Local 19 requires nominations for only one of its two director positions at this time.*
